# **Announcement on Negotiated Procurement**

#### I. Project Overview

- 1.1 Procurement Item: Decoration Works of the Tourist Service Center on the right side of the International Arrivals Hall at Siem Reap Angkor International Airport in Cambodia
- 1.2 Construction Site: On the right side of the International Arrivals Hall at Siem Reap Angkor International Airport in Cambodia
- 1.3 Implementation of procurement funds: Self-raised by the Company

#### II. Scope of Procurement and Relevant Requirements

2.1 Scope of Procurement: Tourist Service Center on the right side of the International Arrivals Hall at Siem Reap Angkor International Airport, with a total construction area of 95 m², including ground filling with 22 cm thick C15 concrete, laying of 800\*800 glazed tiles, customized 24 m² cabinets, anti-corrosion wooded ceiling, circuitry redesign, wood veneer based with flame retardant board, stainless steel dividing strip edge sealing, one partition wall with light steel keel, one wooden door, one set of artificial stone bar counters with customized cabinets, and two sets of electric sensor doors. For the circuitry redesign, collaboration with the Purchaser for power supply and signaling of advertising display equipment (monitor, light box, etc.) will be required. For details, please refer to the bill of quantities for decoration.

- 2.2 Construction period: 40 calendar days.
- 2.3 Quality requirements: Ensure compliance with the current construction acceptance specifications and standards of the People's Republic of China and the Kingdom of Cambodia, and achieve successful acceptance on the first attempt.

#### III. Qualification Requirements for Applicants

3.1 Qualification requirements: Cambodian companies are required to hold a valid business license issued by the Kingdom of Cambodia, covering construction engineering activities. Additionally, they shall possess valid tax and VAT registration certificates, and have the capability to issue VAT invoices.

## Note: Copies of valid business license, VAT certificate and tax certificate shall be provided.

3.2 Business performance requirements: The company must have successfully undertaken at least 1 (included) decoration project within the last five years (from January 1, 2018, to the present).

## Note: The contract shall be provided.

3.3 Quotation from joint venture is unacceptable for this procurement.
